ANNUAL REPORT OF THE EXAMINATION CELL NORTH LAKHIMPUR COLLEGE (AUTONOMOUS) <u>2019-2020</u>

Prelude:

North Lakhimpur College was granted autonomous status for the academic level from the session 2013-14 vide UGC letter no. F. 22-1/2013 (AC) dated 22nd May, 2013 New Delhi.The Examination Cell, North Lakhimpur College (Autonomous) was established in May, 2013 as per the UGC regulations of Autonomous College. Under the autonomous system the college has set up an '**Examination Cell**', as per regulation provided in the guidelines of Autonomous Colleges prepared by UGC.The Principal of the college is the Chief Controller of Examinations. The Examination Cell is headed by the Controller of Examinations with two Deputy Controller of Examinations to assist him. The previous examination ordinance 2013 is modified to accommodate the CBCS and to rectify few clauses. This ordinance will be referred to as the Examination Ordinance 2019. All examination related matters are governed by the Examination Ordinance, 2019 of North Lakhimpur College (Autonomous).

Examination Pattern:

The Collegehasintroduced the CBCS (choice based credit system) for UG and PG programmes from this academic year. Usually two exams are conducted per year after the end of each semester atboth UG and PG levels. The UG and PG examination is conducted in the following way as per the regulations of examination manual.Following the COVID 19 related guidelines from UGC, the college promoted the 2nd and 4th semester students to the next higher semesters based on their previous semester and internal assessment marks. The 6th semester examination (CBSS) was conducted via both online and offline mode. The academic year is extended up to September, 2020. Course wise/programme wise time table is published and announced well inadvance. For each examination one external Senior Supervisors is nominated. The Principal or hisnominee acts as Internal Senior Supervisor and also Custodian of Questionpapers. Immediately after the examination, written answer books of students are sent in sealed cover to office of the controller for coding and central evaluation. A student must complete minimum 144 credits (for CBCS) and 120 credits (for CBSS) to complete his/her B.Sc. / B.A. /B.C.A. programme and 40 (for CBCS & CBSS) credits for P.G.D.C.A. programme.A student must complete minimum 80 (for CBCS) and 70 (for CBSS) credits to complete his/her M.Sc. / M.A./B.PEd programme. A candidate shall be declared as passed in a course, provided M.Sc. / M.A./B.FEG programme. I candidate in the End-Semester Examination and at least he/ she secures at least 40% marks in the course in the End-Semester Examination and at least 40% marks in the aggregate in the 'In' and 'End' Semester Examination.
