**1. Preamble :**

This Memorandum of Understanding (MOU) is executed on this day 01.08.2024 between  
DISTRICT LITERACY MISSION AUTHORITY CUM INSPECTOR OF SCHOOL,  
DISTRICT ADULT EDUCATION OFFICER, i/c LAKHIMPUR, ASSAM

AND

NORTH LAKHIMPUR COLLEGE (Autonomous), established in 1952 and an  
Autonomous College affiliated to Dibrugarh University in North Lakhimpur. North Lakhimpur  
College herein after referred to as "SECOND PARTY/ NORTH LAKHIMPUR COLLEGE",  
is the autonomous college in Assam. Presently there are 21 Departments having Science, Arts,  
Physical Education and ITEP, represented by its Principal Dr. Biman Ch. Chetia.

Department of Education was established in 1981 in North Lakhimpur College without Major  
course. The Major course was introduced in 1987-88 with a limited number of seats. At  
present, the department has a unique position. The students from this department not only  
succeed in the under graduate course but also secured top positions in the Master Degree level.  
The Department introduced the M.A. Courses from 21st October 2021. The Department has  
also introduced the Ph.D Programme in 2023. The department of Education also carries an  
interdisciplinary course on *Foundation Courses on Human Rights and Duties* as well as on  
extension educational activities, field activities and also the Departmental Library for the  
benefit of students.

**2. Purpose**

That the broad objective of this agreement is to have a common platform for summer & winter  
Internship/Resource Person/jointly organizing Seminar, Workshop/Projects/Action Research/  
Joint Training Programme/Effective implementation of NEP-2020.

**3. Statement of Mutual Benefits & Interests:**

- a. Together, these two parties shall work towards furthering cooperation in Internship, Action research and organizing programmers, exchange of Resource Person which will be mutually beneficial for both the department.
- b. Parties shall work in cooperation for research activities, exchange of Resource Person, Joint Programmes, sharing of information, Summer & Winter Internship etc.

**4. Forms of Cooperation :**

The parties envisages the following cooperation within the scope of this Memorandum of Understanding (MoU)

- a. Exchange of Resource Person
- b. Conduct of Action research
- c. Seminars /Symposia/ Workshop Programs to be jointly organized
- d. Internship

**5. Financial Obligations:**

There will be no financial obligations on both the parties under this agreement

**6. Legal Relationship:**

The MoU shall be constructed as a statement of purpose to promote a genuine and mutually beneficial collaboration between the parties. Nothing in this MoU shall be constructed to create any legal relationship between the parties.

**7. Coming into Force, Amendment and Termination:**

This MoU shall come into force from the date of its signatures and remain valid for a period of 5 years. This MoU may be modified, renewed or extended with the mutual written consent of the Parties. Either party may terminate this MoU by giving six (6) months' notice in writing to the other party.


