1.0 Introduction

This Agreement is executed between Office of the District Social Welfare, Lakhimpur District and North Lakhimpur College [Autonomous]. It specifically involves the academic and consultancy cooperation between Office of Social Welfare, Lakhimpur and North Lakhimpur College [Autonomous].

2.00 Aims and Objectives

2.01 Research Collaboration

2.01.01 Research Projects

Both the institutes will seek help from each other to accomplish different research projects sponsored by either UGC or any other funding agencies. Especially both the institute will help each other as co-investigators. Moreover self funded projects will also be carried out together.

2.01.02 Seminars

Mutual support will be sought while conducting seminars or conferences sponsored by either UGC or any other agencies. Moreover support will be sought in self sponsored seminars too.

2.01.03 Academic Cooperation

A good academic bonding is expected to be created between Office of Social Welfare and North Lakhimpur College [Autonomous]. Office of Social Welfare shall be able to invite faculty members from North Lakhimpur College [Autonomous] as Resource Person to deliver lectures on awareness Programmes on Social Welfare. In the same way North Lakhimpur College will also be able to invite members from Office of Social welfare as resource person to participate in the awareness programmes. Moreover the Office of Social welfare will agree to facilitate graduate and masters students as interns for a specific period of time. In this regard the decision will be taken only after a mutual discussion between the institutions.

2.02 Extension Activity

2.03.03 Preparation of Area Specific Models for Social Welfare


North Lakhimpur College will provide necessary Area Specific Models for Social Welfare in the Lakhimpur District wherever feasible for the College.


3.00 Financial Support


