2. **YOGA TRAINING AND TRATMENT CENTER, (YTATC) C.D. ROAD, NORTH LAKHIMPUR, DIST – LAKHIMPUR, ASSAM**, represented by Dr. Chandan Kumar Medhi, Principal , YTATC, C.D. Road, North Lakhimpur, is called the academic partner.
3. **MRS RUMI BORPATRA GOHAIN**, aged 38 yrs, C/O- MR MONTU BORPATRA GOHAIN, VILL- GANDHI NAGAR, SILAPATHAR, DIST- DHEMAJI called the third party (co-ordinator of satellite study centre).

Whereby it is agreed that the parties hereto (hereinafter together called the "Collaborator) **North Lakhimpur College and YTATC** unanimously decided in the meeting to start a satellite study centre within the campus of CITY CENTRE COMPLEX, NEAR DONBOSCO SCHOOL, SILAPATHER, DIST – DHEMAJI, upon the terms and conditions hereinafter contained namely..

And whereas with a view to defining rights, relation and obligation of the "collaborator" interest and to avoid any dispute in future the parties have considered expedient and necessary to execute a deed of agreement w.e.f...~~2~~<sup>3</sup> day of ...~~June~~<sup>June</sup>, 2019 on the terms and conditions herein\*after appearing.

**NOW THEREFORE THIS AGREEMENT WITNESSETH AS UNDER**

1. **THIS MOU** is following the previous mou done on dated 25<sup>th</sup> August, 2017.
2. **COMMENCEMENT OF THE INSTITUTE** :- that the institute will work jointly in the name of North Lakhimpur College & YTATC.
3. **ACTIVITIES OF THE INSTITUTE** :- that the activities of the institute will ordinarily be a educational & vocational & skill development institute and government projects.
4. **CAPITAL** :- that the initial capital of the Institute will be brought in by the "Collaborator" @ 50%+25%+25%=100% that is 50% will be Represented by YTATC (Academic partner), 25% will be represented by NL College(Host institute) and 25% will be represented by co-ordinator of setalite each.
5. **DISTRIBUTIN OF POFIT & LOSS** :- that the "Collaborator" hereto shall participate in the profit & losses as per the Para 4 of this Agreement.
6. **ACCOUNTING YEAR** :-accounting year of the Institute shall be from 1<sup>st</sup> April to 31<sup>st</sup> March of the subsequent year. An account shall be prepared at the end of each year to determine the net profit or losses made during the year. The account of the Institute shall be maintained according to the financial year, from 1<sup>st</sup> April to 31<sup>st</sup> March and general account shall be taken every year. It is mutually agreed that an authorized/ independent Chartered

Accounts Firm shall be engaged (if necessary) for the purpose and a copy of the accounts shall be furnished to each of the collaborator.

**7. BANK ACCOUNTS :-** That the Existing Account of NL College of Axis Bank A/C No – 914010032503781 shall be operative.

**8. MANAGEMENT :-** that the "Collaborator" shall have equal rights in the control and management of the side Institute office regarding courses provided. That at the end of each financial year the books of accounts shall be drawn up and profit ascertained for the year shall be distributed amongst the three parties according to their respective shares as laid down in clause 4 herein before. In case of loss (if any) they shall bear the same according to their respective shares.

**9. THE HOST INSTITUTION SHALL :-**

- i) Admit students for the programme by finalizing the entry level terms and conditions such as performance in the qualifying examination etc.
- ii) Shall receive the admission fee and other fee as fixed by the host institution from time to time as finalized after meeting of the advisory committee of the programme.
- iii) Shall design the curriculum of the programme as per conditions provided in the regulations of North Lakhimpur College (Autonomous) in consultation with the experts from the partner institute by emphasizing on its content.

**11. THE YATC SHALL :**

- i) Provide technical expertise in areas such as curriculum design and classroom teaching (as guest faculty) as and when requested at their convenience.
- ii) Participate in the process of curriculum designing by taking into consideration the contemporariness of the course content and employability of the students
- iii) Give one academic year's notice to the host institution in case of any unilateral decision to discontinue technical, infrastructural and logistical support to the programme
- iv) Shall conduct theory cases and practical sessions as per course curriculum.
