### MEMORENDUM OF UNDERSTANDING

This MOU is made on this 23 day of Jun, 2022 between and among the following respective institute :-

1. NORTH LAKHIMPUR COLLEGE (Autonomous) affiliated under Dibrugarh University, represented by Dr. Bimman Ch. Chetia, principal, North lakhimpur college (Autonomous), Northl Lakhimpur College, Assasm is called the host institute.

2. YOGA TRAINING AND TREATMEN CENTRE (YTATC), C.D. Road, North Lakhimpur, Assam, represented by Dr. Chandan Kr. Medhi, Principal, YTATC, C D Road, North Lakhimpur, is called the academic partner.

Whereby it is agreed that parties hereto (collaborators) North Lakhimpur College (autonomous) and YTATC unanimously decided to continue the yoga courses running which is enrolled in the physical education programme within the campus of North Lakhimpur College (autonomous) upon the terms and conditions hereinafter contained namely mentioned below...

1. DURATION OF MOU:- That the duration of the agreement is not limited to any length of time until determined in accordance with the terms hereafter contained.

2. COMMENCEMENT OF THE INSTITUTE:- That the institute will work jointly in the name of North Lakhimpur College and YTATC.
3. ACTIVITIES OF THE INSTITUTE :- That the activities of the institute will ordinarily be a educational and vocational and skill development institute and government projects.
4. CAPITAL:- That the initial capital of the institute will be brought by the collaborator @ 65%+35% =100% that is 65% represented by YTATC (academic partner) and 35% will be represented by N.L.College (host institute) each.
5. DISTRIBUTION OF PROFITS & LOSS:- That the collaborator hereto shall participate in the profit & losses as per the Para- 4 of the agreement.
6. ACCOUNTING YEAR:- Accounting yeae of the institute shall be from 1<sup>st</sup> April to 31<sup>st</sup> March of the subsequent year. An account shall be prepared at the end of the each year to determine the profit or losses made during the year. The account of the institute shall be maintained according to the financial year, from 1<sup>st</sup> April to 31<sup>st</sup> March and general account shall be taken every year. It is mutually agreed that an authorized or independent chartered firm shall be engage (if necessary) for the purpose and a copy of the accounts shall be furnished to each of the collaborator.
7. BANK ACCOUNTS:- The existing bank account of N.L. COLLEDGE of Axis bank A/C No- 914010032503781 shall be operated.
8. MANAGEMENT:- That the "collaborator" shall have equal rights in the control and management of the side institute office regarding courses provided. That at the end of each financial year the books of account shall be drown up and profit ascertained for the year shall be distributed amongst the collaborator according to their respective shares.

9. RIGHTS OF THE COLLABORATOR:- That each of the "Collaborator" shall be together agreed upon (and give consent in writing), entitled:-

- a. To prepare, finalize the curriculum jointly.
- b. To provide certificates to the students successfully completed the training programme (both theory and practical) with joint name and logo of both collaborator.
- c. To prepare /revised Fees structure.
- d. To introduce FOUNDATION COURSE IN YOGA, CERTIFICATE COURSE IN YOGA, DIPLOMA COURSE IN YOGA & POST GRADUATE COURSE IN YOGA etc.
- e. That the centre will be the host institute.

10. THE HOST INSTITUTE SHALL:-

- (i) Admit students for the courses by finalizing the entry level terms and conditions such as performance in the qualifying examination etc.
- (ii) Shall receive the admission fees and other fees as fixed by the host institute from time to time as finalized after meeting of the advisory committee of the programme.
- (iii) Shall design the curriculum of the programme as per conditions provided in the regulations of North Lakhimpur College (autonomous) in consultation with the experts from the partner institute by emphasizing on its content.
- (iv) Provide adequate competent faculty (in house as well as guest), class rooms and laboratory facilities for the students.
- (v) Shall conduct theory and practical sessions as per course curriculum.

(i) Provide technical expertise in areas such as curriculum design and classroom teaching (as guest faculty) as and when requested at their convenience.


(ii) Shall conduct theory and practical sessions as per course curriculum.


(iii) Participate in the process of curriculum designing by taking into consideration the contemporariness of the course content and employability of the students

(iv) Give an academic years notice to the host institutes in case of any unilateral decision to discontinue technical, infrastructural and logistical support to the programme.
